AGES and the College have established this programme for senior trainees to help facilitate the skill steps that are required to perform these procedures.

AGES has assembled an expert faculty of laparoscopic surgeons. The programme involves both lectures

including videos/demonstration as well as an extensive skills labs component and is held at the Royal Australasian College of Surgeons Simulation Centre.

We will also have a strong suturing component at this workshop.
